

Use of the Mental Health Act is increasing in New Zealand.

Data published by the Ministry of Health suggest that use of the Mental Health (Compulsory Assessment and Treatment) Act is increasing in New Zealand. The latest figures (contained in the Office of the Director of Mental Health Report for the 2011 calendar year) show the highest rates of compulsory care since the Ministry began publishing figures in 2006. Use of section 11 (used in acute crisis) has shown no significant increase, but the use of community treatment orders, shows a steady increase since 2009. Between 2005 and 2008 the national average rates of use of community treatment orders was stable at between 57 and 60 per 100,000. However in 2009 the rate increased to 63 per 100,000, and in the following years to 76 (2010) and 83 (2011). In addition to increases in overall rates there is significant geographical variation in use of community treatment orders, with the highest user in 2011, Waitemata DHB, using 151 orders per 100,000, almost five times the rate of the lowest user (Canterbury DHB) which used 33 orders per 100,000.

# Report from President Daryle Deering

Tena koutou katoa Dear mental health nursing colleagues Hoping 2013 has started well for you and your families and whānau and that you rise to the challenges that this year brings.

The key event this year is the first Australasian Mental Health and Addiction Nursing Conference *Close to Home* to be held in Auckland 19<sup>th</sup> – 21<sup>st</sup> June. Please consider attending and apply early. The College biennual conference provides a unique opportunity to come together as mental health nurses.

This inaugural conference hosted jointly by the Auckland Branch of Te Māramatanga NZCMHN and Drug and Alcohol Nurses of Australasia Inc (DANA) recognises the lived experience of many people, and their families and whānau, of the impact of experiencing substance use and mental health problems which are frequently intertwined. The increasing need for mental health nurses to provide flexible and responsive care that is person and family centred rather than service centred is reflected in the revised Standards of Practice which will be formally launched at the conference. The revised Standards will underpin Certification which will provide a vehicle for professional rec-


ognition of the specialist practice of mental health nurses.

In order for mental health nursing to continue to expand and grow, barriers to unleashing the potential of nursing need to be removed. This requires both organisational and policy changes at national level as well as the courage to work to the top of our scope as mental health nurses and a willingness to enhance our professional practice. For example, Nursing Council is currently consulting on registered nurse prescribing. It is important that as mental health nurses we provide input and support the direction outlined in the document.

At a College level, National Committee will be proposing changes to the structure of the College together with suggested accompanying changes to the Constitution - in order to support the next phase of College development. An outline of proposed changes and the rationale will be disseminated to all members and put up on the website for consideration and addressing at the annual general meeting to be held during the conference. As a College member, please look out for this information and ask any questions you may have as early as possible. It is important that the proposals are considered, discussed and most importantly that you are involved in this process.

# Guest Editorial from Tony O'Brien (contd)

The overall increases are concerning given the "closer to home" strategic direction of the Mental Health Commission outlined in the recent Blueprint II documents. The Blueprint document *Making change happen* states that "Our current community mental health and addiction resources are a success story of the last decade" (p. 137). However if we are to be able to continue to make that claim we will need to address the increase in the use of community treatment orders. There may be a variety of reasons underlying the reported data. Recent changes in the system of reporting may mean that recent data are now more accurate and that the lower rates of previous years were an underestimate. Another possibility is that shorter lengths of inpatient stay may lead to people being discharged with higher levels of symptoms and unmet need. It is also possible that, in some DHBS at least, clinicians are becoming more risk averse and so are using the compulsory provisions of the Act to compel service users into treatment. Whatever the reasons, and they are likely to be multiple, nurses need to be continually vigilant about the use of compulsion in mental health care.

### UPDATE from Jo Harry Credentialing Project Manager

**Branch support** – currently the College is looking at investing time and energy into branches and are wanting to assist with developing a professional development series located in centres that are interested. **Credentialing** – This project continues to forge ahead, and has generated much interest amongst PHOs in New Zealand. In fact, we have also had inquiries from NZ nurses living in Australia. More recently the Evaluation and Monitoring Framework was completed and is now on the website, in the form of a handbook, for any interested parties. This handbook provides a road map for primary healthcare nurses and PHOs who wish to seek a *mental health and addiction credential in primary care*.

Credentialing is a process used to assign specific clinical responsibilities to health practitioners on the basis of their education. It commences on appointment and continues for the period of employment. A credential recognises the skills of an individual to perform agreed clinical activities within a designated environment, and in this case that is general practice settings.

As time passes, nurses working in primary care settings and Primary Health Organisations are becoming increasingly interested in seeking a *mental health and addiction in primary care credential*.

We are pleased to be working alongside Manaia Health PHO in Northland as they embark on training to up-skill and enhance confidence with a select group of practice nurses. I must make mention of one of our College members working for Manaia who has been integral in this process and who is taking a lead role in the practice development support offered to this group of nurses – thank you John Hartigan!

**Certification** -Certification is a form of credentialing. The College defines certification as 'the formal recognition that an individual meets the standards of mental health nursing, established by NZCMHN'. This is applicable to all mental health nurses in New Zealand and the college hopes to release this process later this year. Work is currently being completed on this. Exciting times ahead as we may soon be able to officially claim the title Mental Health Nurse.

We are also excited to be talking about credentialing in the corrections settings; discussions are currently under way. Heather Casey has been active in setting things in motion. Kapai Heather.






# **Eating Compulsivity Study**


