

PRESIDENTS COMMENT

Dear colleagues

Firstly, I want to acknowledge the conference committee, led by Mel Green, for the highly successful Southerly Change Conference in July. It was a great conference to be part of. I have had numerous mental health nurses tell me how much they enjoyed the workshops and the two conference days. Our Patron, Dame Margaret provided support for the College Accreditation, Certification and Credentialing Framework and encouraged mental health nurses to utilise our skills to provide assistance to people both during and following disasters such as the Christchurch earthquake. The College has provided an evaluation of the workshops undertaken by Frances Hughes and Margaret Grigg for Minister Ryall together with a number of recommendations. These include website resources for nurses, follow-up workshops and incorporation of psychosocial responses to disaster in education programmes for all health professionals. Professional development is an important area for the College to develop, building on local Branch initiatives and initial national workshops on nurse practitioner and psychosocial response to disasters.

Since the conference my time has been taken up with meeting with key stakeholder groups with Heather Casey, Director of the College Accreditation, Certification and Credentialing Framework, to provide presentations on the Framework. There has been considerable confusion over terminology and purpose, which we are systematically addressing. Catherine Coates (Project Manager Credentialing) and Jo Harry (increased administration time) have been working on communications. More information will start to appear on the College website now that the Credentialing Project for ProCare practice nurses has been finalised with Health Workforce NZ. This is an exciting project that will provide the College with the opportunity to work in partnership with a PHO to enhance the skills of practice nurses in the areas of mental health and addiction. Such skill enhancement is in keeping with the primary health care role of practice nurses in the areas of health promotion and early intervention as well as in contributing to the provision of continuing general health care for

people with mental health and addiction problems following periods of more intense treatment.

During the next few months I plan, with other members of National Committee, to have a focus on strengthening College relationships with national consumer and service user groups and other professional bodies. Hineroa and I will be attending the Australian College of Mental Health Nurses conference in early October and this provides another opportunity for discussions with our Australian mental health nursing colleagues on key strategic issues. We will include a report of discussions and the conference in the next newsletter. The College has renewed the memorandum of understanding (MOU) with Kites Trust and formalised a MOU with the Drug and Alcohol Nurses of Australasia (DANA). The College continues to have a high level agreement with Te Pou and is represented by Mel Green on the the Te Pou Nursing Advisory Group. A focus on strengthening

sponses to consultation documents. In respect to DANA, the Vice President International is Louise Leonard, a clinical nurse specialist at the Waikato DHB who is on the nurse practitioner pathway. Louise's clinical role crosses addiction and mental health.

I want to acknowledge the recent appointment of Frances Hughes to the role of Acting Deputy Director of Mental Health and Principal Clinical Advisor for the Ministry of Health. This is the first time a nurse has held this position and this appointment recognises France's expertise.

I want also to acknowledge mental health nurses in front line practice and leadership roles during periods of workplace stress and difficult circumstances. At time difficulties arise in most mental health service settings which provide significant challenges for staff at all levels of the organisation. The College is very willing to provide input from a professional mental health nursing perspective on any occasion when this would be consid-

Biography

My ethnicity is Maori / Cook Islander. My iwi (tribal) affiliations are; Ngati-Maniapoto, Ngati Kahu-ki-Whangaroa, Ngati-Makea (Cook Islands)

I have worked in the mental health field since 1974; the last 30 years in psychiatric/mental health nursing. My interest in mental health started as a 17-year-old college (high school) student, with volunteer work at Tokanui Hospital, during the national-wide strike by psychiatric nurses in 1971.

In 1974 I started work as a student training officer at Levin Hospital & Training School. At the end of 1974 I transferred to Tokanui Hospital and worked as a training officer, (working with children with a moderate to severe intellectual disability), for 7 years. In 1981 I was accepted to do my psychiatric nurse training. I registered in 1984. I gained my Advanced Diploma in Nursing in 1989, completed the bridging to RCpN, Diploma in Nursing in 1994, gained my Bachelor of Nursing in 1998, and graduated with a clinical Master of Nursing in 2006.

My mental health nursing experience over the years has included acute, rehabilitation, forensics, elderly, therapeutic milieu, crisis, project work, nursing education, clinical supervision, mentorship / preceptorship and community counselling/nursing.

The highlights of my nursing career have been; developing mental health nursing clinical expertise working in a large institution, nursing in a community setting attached to a large institution, psychiatric/mental health crisis team, clinical supervisor to student nurses (ensuring students experienced psychiatric/mental health nursing in a positive environment), clinical nurse consultant (rural/remote mental health project in Outback Australia), working group in the development of generic Risk Assessment training, rural perspective to advisory group for development towards DSM V, and clinical nurse consultant (at regional mental health level).

I have been a member of the College since it's New Zealand inception in 1993. I was part of the Waikato branch of the organising committee for the 1995 College Conference in Hamilton, and currently I am a College Practice Board member.

My purpose in seeking nomination for the vacancy is to be involved in the ongoing professional development of mental health nursing at a national level. My aim is to ensure that mental health nursing, through NZCMHN (Te Ao Maramatanga), develops and maintains a high profile professionally, academically and politically.

All that I espouse to be as a mental health nurse sits within the College objectives.

I am a community mental health nurse with Lakes DHB in the Southern Lakes region of Taupo / Turangi / Mangakino.

I eventually, or is it finally realised that the College isn't a lot of people sitting somewhere away from here... people on the executive, working for the greater good, sending out important emails! No, I realised that the college is me. Us, each individual, and that we all need to contribute, communicate and participate, provide feedback, or it wont be a happening thing. Perhaps I took on the messages from some of the Keynote speakers: Professor Dawn Freshwater, <u>Critical consciousness</u>: opening up ideas for thought around the need for political activism, and the need to be politically active in taking the nursing profession forward; Professor Shirley Smoyaks short presentation on <u>Writing for publication</u>: highlighting some of the basic processes required for writing and publication., that publishing does not all need to be academic, but may and should include writing newsletter articles and reports, publishing minutes, Journal articles and contributing to a book chapters.

So to branch business:

We have had fluctuating attendances at recent meetings, wondering if perhaps the fact that we had 9 members attending conference has any bearing on this . Still all exhausted after the wonderful hospitality and experience in Dunedin!

Seriously we do spend time each meeting discussing ways to increase and maintain our branch membership. While recent attendances may have been small, there has been vigorous and robust discussion on a number of topics, including the Enrolled nurse programe, Challenges in gaining College membership from new graduates/ students; and ethics and professional safety.

A number of our members have been extremely active in the College over the years, - 4 branch members are College fellows, and we hope in the future to use some of their passion to encourage others.

This year our membership has changed . There is no longer a predominance of DHB nurses, in fact we have representatives from NGOs, DHB - inpatient, community and management; independents, (nurses unattached to any organisation); tertiary providers and nurses from Primary mental health

care areas. This brings different perspectives into each discussion. To date our great initiative from last year to award 2 new graduates with membership has not translated into their active attendance at meetings.

Clinical reality has meant that our chair Lesley has had to relinquish the role, and at yesterdays meeting, Louise van den Berg, our branch secretary, very kindly agreed to temporarily take on the chair role (with support) for the next 3 meetings, until our next election in December. The Crimes Amendment Bill (No 2) creates an offence of failing to take reasonable steps to protect a child or vulnerable adult from the risk of death, grievous bodily harm, or sexual assault. For the first time in New Zealand, Te Ao Märamatanga New Zealand College of Mental Health Nurses is offering a policy scholarship for mental health nurses to work in a government agency. The policy scholarship funded by one of the college fellows and is the "Frances Hughes policy scholarship".
